DRC's Integration Circle



- A dignified life as a vision for integration activities: Support and enable refugees and migrants to be part of a community and to enjoy equal rights and opportunities in Denmark.
- Language proficiency, employment, participation in civil society, and an inclusive society are pivotal for the quality of life, empowerment and future possibilities of refugees and migrants.
- Meeting the individual with a focus on resources.

War in Ukraine

Since 24 February

- 7.6 mill. refugees
- More than 7 mill. IDP's
- Appr. 34,000 applied for residence in Denmark
- Most women and children

- Mine action



Special law

- Residence permit eligible for:
 - 1. Ukrainian citizens and refugees with asylum in Ukraine, who left Ukraine 1 February 2022 or later
 - 2. Same group if in Denmark or had residence in DK 1 February 2022
 - 3. Close relatives to above mentioned groups
- Temporary residence permit untill 17 March 2024, can be extended to 17 March 2025
- Fast-track procedure
- Special law largely mirrors EU directive
- Immigration Service decides which municipality you are referred to
- Municipalities given more time to provide parts of the integration services

The Danish Integration Act

- Quota system dispersing refugees to (almost) all municipalities
- Programme for integration up to 5 years
- Responsibility of municipalities individual plans



Entitlements:

- Affordable housing
- Free Danish language tuition
- Help finding employment
- Self-support and return benefit (low)
- Health care, mental and social care (trauma rehabilitation etc.)
- Children to daycare, school...


Obligations – 37 hours per week:

- Attend language training and pass test
- Actively participate in employment promoting schemes

What do we know?

- Many women and children
- Refugees from Ukraine is diverse group
- In some ways Ukraine is similar to Denmark, in some ways different
- All have experienced war and fleeing, but in various ways
- People react in various ways to what they have experienced
- Children with same needs as all other children, but some are having very hard time


All refugees are shaken




- Extreme conditions and events

- Fundamentally changed situation

Need for holistic approach



Important in first phase



Conditions in exile are crucial

Risk factors:

- Uncertainty about asylum and stay
- Separation from family
- Lack of network
- Low socio-economic status i exile
- Loss of status
- Language barriers
- Perceived discrimination

Protective factors:

- Family reunification
- Social network
- Employment (or education)
- Language proficiency
- Permanent housing
- Access to health services

Status now

- Reception of Ukrainians positive example of what can be achieved with collective will and effort
- Municipalities under pressure (e.g. housing and schools)
- Many in employment already, many still not
- Children and elderly
- Some struggle with wellbeing
- Some have gone back
- Winter is coming...

- Various hotlines (for volunteers, professionals, Ukrainians)
- Courses and training
- Translated info-material to Ukrainian

- Scaling up volunteer network
- Psycho-social group programs (MindSpring), and play groups for children
- Professional psycho-social support
- Screening project for some municipalities (labour market)
